THEME:
**NEW ERA IN GLOBAL ENERGY LANDSCAPE:
IMPLICATIONS FOR AN EMERGING ECONOMY**

The potential impacts of the emerging era in global energy landscape cut across geopolitics, climate change, energy market structure and advancement in technology. Energy diversification, energy security, energy accessibility at affordable prices as well as sustainability and optimization of primary energy sources are germane to global energy policy debate, more so, for emerging economies that are producers of primary energy resources. Nigeria for example, has overtly dependent on hydrocarbon production for revenues rather than for value creation, which has hindered its economic growth and development potential.

The theme for the 11th NAEE/IAEE Annual International Conference in Abuja is relevant given the changes in the global energy landscape and market structure. There are abundant primary energy resources globally even as traditional energy importers are now emerging as energy exporters. New key players have emerged in fossil fuels supply, especially the US, Russia and Brazil. These non-OPEC producers are increasingly influencing global oil and gas trade, crude oil prices and other market dynamics. Additionally, there are new key players on the demand side with increasing demand for energy-intensive goods with profound impact on global energy market outlook. The 2018 conference seeks to discuss, debate, and proffer sustainable policy framework to address the implications of the New Era in Global Energy Landscape on an Emerging Economy, like Nigeria.

CONCURRENT SESSION

ABSTRACT FORMAT

Those offering to make concurrent session presentations must submit an abstract that briefly describes the research or case study to be presented. The abstract must be no more than two pages in length, and must include the following:

- Overview
- Methodology: Technique used,
- Results: key and ancillary findings,
- Conclusions, and references (if any).

All abstracts must conform to the structure and submitted to admin@naee.org.ng on or before January 5, 2018.

PRESENTER ATTENDANCE AT THE CONFERENCE

At least one author of an accepted paper or poster must pay the registration fees and attend the conference to present the paper or poster. The corresponding author submitting the abstract must provide complete contact details including company/university name, email address, phone number and fax number (where available). While multiple submissions by individuals or groups of authors are welcome, the abstract selection process will seek to ensure as broad participation as possible. Therefore, each author may present only one paper or one poster in the conference. No author should submit more than one abstract as its single author. If multiple submissions are accepted, then a different author will be required to pay the registration fee and present each paper or poster.

STUDENT EVENTS

Students may, in addition to submitting an abstract, submit a paper for consideration in the NAEE Best Student Paper Award Competition. The abstract format and submission process for the poster session is identical to that for concurrent session papers.

KEY DATES TO NOTE

Deadline for abstract submission is not later than January 5, 2018. Authors will be notified of the status of their submission by February 2, 2018. Authors whose abstracts are accepted will have until March 9, 2018 to submit their final papers and presentation for publication in the conference proceedings.
